 - Services are not specific/individualized services. They are community based, so the boundaries are more fluid.
 - Possibly: Egg Harbor City, Galloway, EHT, Pleasantville, EHT, Somers Point, and contiguous to those areas.
 - They do not have to be areas that are touching, but would look extremely scattered if we don't choose touching areas.

 - Is the grant population based or is it based on sq mileage??
- Gretchen- You could pick anywhere and justify it
 - Where will we have success?
 - What communities are already on board?
 - EHT has people on board already; Galloway EMS, EHT PD, Pleasantville has a good presence with us.
 - Somers Point middle schools might have higher absenteeism than Northfield/Linwood
- Kathy Somers Point, EHC are high need
 - A lot of JTAC members are from treatment facilities
- Brian- Focus on White Horse Pike?
 - Does it have to be a municipality or can it be a corridor?
 - Brian shared ODMAP
 - A lot of markers were on WHP
